A ROUND OF THE 2008 ACU TRAIL BIKE CHAMPIONSHIP

SUPPLEMENTARY REGULATIONS AND ENTRY FORM

ANNOUNCEMENT:

The Caerphilly Motorcycle Club will organize a National Sporting Trial for solo machines to be held under the National Sporting Code of the ACU, the 2008 Standing Trials Regulations, the following Supplementary Regulations and any Final Instructions that may be issued.

CHAMPIONSHIP: The event is a round of the ACU British Trail Bike Championship

ELIGIBILITY: All riders must hold a current ACU registration card or Scottish ACU license – Any other riders including Irish participants MUST obtain Personal Accident insurance and produce a license issued by their FMN together with start permission confirming their license and insurance.

EVENT DATE: 13TH July 2008 (SUNDAY)

START TIME: 08:30am Scrutineering; 07:30am

START LOCATION: BEDWAS RUGBY CLUB, NEWPORT ROAD, BEDWAS, CAERPHILLY
On the main road between Newport and Caerphilly. 1 mile east of Caerphilly

THE COURSE: A single lap of approximately 70 miles, using public roads, forestry land, private tracks and BOAT'S around the County of Caerphilly. There will be a number of observed sections marked on punchcards and according to the ACU standing regulations TSR22 (non-stop) i.e.. 0,1,2,3,5 and a timed special test used only as a tie-break.

The special test will be of the form: Start at point A, stop after point B but before point C.

***If a rider passes point C the timing will continue until the motorcycle has come to rest between points B and C ***.

Should a competitor lose his/her punchcard, they should either continue with the trial to the end and sign off as normal, or if retiring from the event inform an official at the earliest possible opportunity. Loss of punchcard will mean exclusion from the results.

Route directions will be by way of a road book and supplemented with Day-Glo arrows where necessary.

IMPORTANT.

The course will use public roads; it is the competitor's responsibility to ensure that their machine conforms to all relevant road traffic regulations and laws and is fully insured for the purpose of the trial. The competitor MUST give way to horses and walkers. Travelling Marshall's will exclude on the spot any rider behaving in a dangerous or irresponsible manner.

CLASSES:

RIDERS MUST SPECIFY ONE CLASS ONLY WITH THEIR ENTRY (except G: team award)

A: CHAMPIONSHIP - AS PER CHAMPIONSHIP REGULATIONS IN HANDBOOK (No 3)

B: PRE - 65 SPRUNG

C: PRE - 65 RIGID

D: FEMALE

E: OVER 45 YEARS OLD (rider - not bike!)

F: CAERPHILLY CLUB MEMBER

G: TEAM AWARD

H: "ROAD LEGAL TRAIL BIKES OTHER THAN IN CLASS A"

The club reserves the right to cancel or merge classes should there be a need.

AWARDS:

PREMIER best ride in the trial

OLD FOGY CUP best over 45 rider

GIRLY CUP best female

BEST CAERPHILLY CLUB MEMBER

TEAM REPLICAS best team

Also: best in class and first class award for the top 10% in each class.

No rider to win more than 1 individual award.

The club reserves the right to merge classes should there be less than 7 entries in the class.

TYRES:

FRONT tyre to be road legal. REAR TYRE TO BE TRIALS PATTERN ONLY (*compulsory*)

(No trials tyre = no ride)

FEES:

ENTRY FEE: £25.00

ACU Registration available to riders who do not currently hold one - £10 (per rider)

ACU Trials Registration cards will be checked at the start

INSURANCE: ALL COMPETITORS MUST HAVE SUITABLE INSURANCE. This can be arranged by the club through the ACU. If required please request details with an extra SAE with your entry.

CLUB MEMBERSHIP: This is a National event, so Centre membership is not necessary. However it is if you wish to compete for the Caerphilly Club Trophy. Club Membership is available for **£10**

TEAM ENTRIES £3.00 per team, included by one rider only, all riders must put team name on entry forms.

Bikes that are presented in an obviously un - roadworthy, illegal or excessively noisy condition will not be allowed to start. YOU HAVE BEEN WARNED!

A noise meter will be at the start

Apart from all that, have a bloody good day and see you in the pub at the finish!

The ACU National Sporting Code and Standing Regulations are published annually in the ACU Handbook.
